

# **OCEAN HILLS SOCIAL CLUB**

### **BYLAWS of the OCEAN HILLS CHORAL SOCIETY**

#### **1. CHARTER**

This Club is a department of the Ocean Hills Social Clubs ("Corporation"), a non-profit corporation, which has approved the Club's charter. The provisions of the Charter are incorporated into these Bylaws by this reference. In the event of a conflict between the Charter and these Bylaws, the Charter shall control.

#### **2. PURPOSE**

The purpose of the Choral Society is dedicated to the performance of all genres of choral music and to provide community singing opportunities to all residents of Ocean Hills. A non-auditioned chorus, the Chorale performs challenging music for the enrichment and education of its members and audiences. Having fun is a requirement while making beautiful music. The Chorale has two concerts a year in Abravanel Hall for all residents, guests, and families.

#### **3. MEMBERS**

- a. **Eligibility** - Residents of Lots within the Ocean Hills Country Club Homeowners Association.
- b. **Dues** - Set by the Club's Board of Directors. Dues will be consistent for all members and will be based on its operating needs and on assessments due the Social Clubs Corporation for its operation, as determined by the Ocean Hills Choral Society Board of Directors and the Ocean Hills Social Clubs Board. All monies collected as Dues shall be used only for operating expenses associated with the intended purpose of this Club (as set forth in Article 2 above) and for assessments due the Social Clubs Corporation for its operation.
- c. **Meetings** - The number of general membership meetings shall be determined by the Club Board of Directors. There must be at least one in-person general membership meeting held in the fourth quarter of the year to elect club officers for the following year.
- d. **Voting** - Any action taken by the Club's members shall require approval of at least a

majority of Club members present at any meeting where such vote is held.

4. **BOARD OF DIRECTORS**

- a. **Elected Officers** - The Officers shall consist of: President, Vice-President, Secretary, and Treasurer.
- b. **Directors** - The number of directors shall be designated by the Club Board and will be voting members of the Board.
- c. **Terms** - Shall be one (1) year beginning January 1.
- d. **Vacancies** - Unexpired term shall be filled by appointment by the current Club Board of Directors.
- e. **Meetings** - Club Board of Directors' meetings will be held as needed. Special meetings may be called at the discretion of the President and / or Board, or if requested by five (5) or more Club Members.

5. **OFFICERS' DUTIES**

- a. **President** - As Chief Executive Officer shall officiate at all meetings and shall attend the "Social Clubs Presidents" meeting or send a representative.
- b. **Vice-President** - Shall officiate at meetings in the absence of the President and perform other duties as directed by the President.
- c. **Secretary** - Shall be responsible for minutes of the Club's board and business meetings, and correspondence. Shall have a current list of all members provided by the Treasurer. Shall retain the Minutes of all meetings in accordance with the Rules and Regulations of the Ocean Hills Social Club.
- d. **Treasurer** - Shall be responsible for keeping all financial records, filing all necessary financial forms, depositing, and keeping account of all funds, and giving reports to the Board and membership as needed. Shall maintain a current list of all members. Shall retain the Financial Records in accordance with the Rules and Regulations of the Ocean Hills Social Club.
- e. **Directors** - Duties shall be outlined by the Club Board of Directors.

6. **NOMINATING COMMITTEE**

By October, the President shall appoint a Nominating Committee Chairperson. The chairperson shall select two (2) additional members to serve on this committee. One of the members should

be a member of the current Club Board of Directors.

The Nominating Committee shall present the proposed slate of officers at a general membership meeting that is held in-person during the fourth quarter of the year, at which time nominations shall be accepted from the floor. Elections shall be at this meeting with officers to take office January 1 of the next year.

There shall be one vote for each office, not cumulative; candidates with the highest number of votes are elected.

## 7. GOVERNING DOCUMENTS

This Club understands and accepts that the edition of the "Rules and Regulations of Ocean Hills Social Club's Corporation", approved by the Corporation's Board of Directors constitutes the basic Rules and Regulations governing this Club. Specifically, this Club understands and agrees to abide by the Code of Conduct and the Code enforcement regulations articulated therein.
